

A) The Parties

St. Anne's Degree college & PG Center, Virajpet, Coorg, Karnataka and St. Aloysius College, Mangalore, Karnataka wish to conclude this Memorandum of Understanding (MoU) to facilitate the development of Management Studies, Computer Science, Economics, Psychology, Accounting, Human Resource, Mathematics and Marketing.

St. Anne's Degree College & PG Center, Virajpet, Coorg, Karnataka and St. Aloysius College, Mangalore, Karnataka recognize their strengths in research and education in the disciplines of Management Studies, Computer Science, Economics, Psychology, Accounting, Human Resource, Mathematics and Marketing and their mutual interest in engaging in academic and research cooperation. Therefore, St. Anne's Degree College & PG Center, Virajpet, Coorg, Karnataka and AIMIT, St. Aloysius College, Mangalore agree to establish a programme for academic cooperation in the areas of mutual interest and in accordance with the terms and conditions set out in the MoU.

B) The Objectives


1. To foster collaboration and provide opportunity to faculty and students of both institutions and to facilitate the advancement of knowledge through academic and research collaborations.

To promote research/ and quality education between the two institutions.

C) Areas of Collaboration

2. St. Anne's Degree College & PG Center, Virajpet, Coorg, Karnataka and AIMIT, St. Aloysius College, Mangalore agree to explore the possibility of engaging in the following areas of collaboration:
 - 2.1) Exchange of faculty and students for a short period.
 - 2.2) Conducting and organizing joint workshops, seminars, symposia and events in areas of mutual interest.
 - 2.3) Investigating possibilities for the development of mutual academic programmes of interest.
 - 2.4) Sharing of knowledge and capacity in areas of mutual interest.
 - 2.5) Exchange of best practices.

3. It is understood that the implementation of any of the types of cooperation stated above shall depend upon the availability of resources and financial support of the parties concerned.
4. Development and implementation of specific activities based on this MoU will be further negotiated and agreed between colleges as applicable, depending on the specific project.

D) Intellectual Property

5. Should the collaborative research activities under this MoU result in any potential for intellectual property, each shall seek an equitable and fair agreement as to ownership and other property interests that may arise according to the rules and regulations of the two institutions.

E) Coordination

6. St. Anne's Degree College & PG Center, Virajpet, Coorg, Karnataka and AIMIT, St. Aloysius College, Mangalore shall name a coordinating committee consisting of teaching /research staff and (a) Principal of St. Anne's Degree College & PG Center, Virajpet, Coorg, Karnataka or his nominee, (b) Director, AIMIT, St. Aloysius College or his nominee, (c) Coordinator from St. Anne's Degree College & PG Center, Virajpet, Coorg, Karnataka (d) Coordinator from AIMIT, St. Aloysius College, will periodically review and identify ways to strengthen cooperation between the two institutions.

F) Activities for Immediate Future

7. A team of faculty research staff from AIMIT, St. Aloysius College and St. Anne's Degree College & PG Center, Virajpet, Coorg, Karnataka, will make it a priority to visit each other's Institute for a short duration for the purpose of conducting workshops, discussions and interacting with each other for the development of mutual Diploma Certificate Courses and research collaborations.

8. A select group of students from both institutions will visit the collaborating institutions to study possible research areas, or to conduct research activity or academic pursuit.

G) Terms and Termination

9. This MoU will take effect from the date it is signed by representatives of the two institutions. It will remain valid for the period of five years and may be continued thereafter after suitable review and agreement.
10. This MoU may, at any time during its period of validity, be terminated by one of the parties upon prior notice to the other in writing not later than six months before the termination date. Once terminated, neither St. Anne's Degree College & PG Center, Virajpet, Coorg, Karnataka nor AIMIT, St. Aloysius College will be responsible for any losses, financial or otherwise, which the other institutions may suffer. However, St. Anne's Degree College & PG Center, Virajpet, Coorg, Karnataka and AIMIT, St. Aloysius College will ensure that all activities in progress are allowed to complete successfully.
11. Any cooperation under this MoU is subject to the availability of funding sources.
12. In the event that either party wishes to disclose any data and/or information supplied in or resulted from the implementation of this MoU, the disclosing party shall have prior written consent from the other party.
13. Any dispute concerning the interpretation and /or application of the MoU shall be settled amicably through consultation between the parties.
14. This MoU may be amended or revised at any time by mutual written consent of the parties, and such amendment shall form an integral part of this MoU.

H) General

15. This MoU may only be amended or modified by a written agreement signed by the representatives of each party.



18. This MoU is signed subject to approval by respective academic / administrative bodies.






